(Orange County, United States, 2/8/10) – The members of the Muslim Student Union at the University of California, Irvine, condemn and strongly oppose the presence of Michael Oren, ambassador of Israel to the United States, on our campus today. Cosponsored by the Law School at UC Irvine, the Israeli ambassador has been invited to speak on our campus, perhaps for representing a state that continues to break international and humanitarian law with disregard to human and moral rights, condemned by more UN Human Rights Council resolutions than all other countries in the world combined.


One year after the horrific massacres committed by Israel and its Defense Force under wide global condemnation, the Israeli propaganda machinery, led by the Israeli ambassador in the United States, has launched PR campaigns aiming to polish the ugly face of the IDF. One year after murdering more than 1400 people in Gaza, the vast majority of whom are civilians, including more than 400 women and children, Israel is attempting to wash the blood off its hand and hide the war crimes it has committed behind deceitful faces of so-called “academics” and “diplomats.” In addition, these campaigns aim to continue to secure more than three billion dollars of American taxpayer’s money that supports Israeli’s criminal military forces on annual basis. We are undergoing the worst economic recession since the great depression, our tuition as UC students is increasing by more than 30% this year, our classes and services are being cut, yet we can continue to afford supplying Israel with billions of dollars worth of brutal weapons used to oppress and inflict suffering on the Palestinian people.

As people of conscience, we oppose Michael Oren’s invitation to our campus. Oren is part of a war machine that has repeatedly attacked and destroyed Palestinian educational institutions, including more than 37 primary and secondary schools just in last year’s Gaza war, depriving innocent people the right to learn and enjoy academic freedoms such as the freedom of speech. As students at the University of California, Irvine, as we cherish and respect freedom of speech, we refuse to grant Israeli officials the rights they deprive innocent people from enjoying.


Michael Oren is no diplomatic or academic figure that deserves respect in a prestigious academic institution. He has personally participated in the Israeli Defense Force's wars in Lebanon and Palestine, being part of a culture that is based on terrorizing the innocent; killing their people, demolishing their homes, stealing their land, humiliating their elderly and weak, and committing war crimes against them. Oren has served as a wartime paratroop officer in Lebanon and has volunteered as a military liaison officer during the attacks on Gaza last year. FOR IMMEDIATE RELEASE

The members of the Muslim Student Union at the University of California, Irvine, condemn and strongly oppose the presence of Michael Oren on our campus today. We resent that the Law School and the Political Science Department have agreed to cosponsor a public figure who represents a state that continues to commit human rights violations, thereby breaking international law and law of Israeli accord. We strongly condemn the university for cosponsoring, and therefore, inadvertently supporting the ambassador of a state that is condemned by more UN Human Rights Council resolutions than all other countries in the world combined.

A year after the war on Gaza, in which 1,400 people were massacred, 700 of whom were women and children, Israel attempts to hide the war crimes it has committed behind the deceitful facades of so-called "academics" and "diplomats". These public relations campaigns aim to secure more than three billion dollars of American taxpayer money that supports Israel's military forces on an annual basis. The United States is going through the worst economic recession since the great depression, our tuition as UC students is increasing by more than 30% this year, our classes and services are being cut, and yet we continue to supply Israel with billions of dollars worth of brutal and illegal weapons used to oppress and inflict further suffering upon the Palestinian people.

To further understand why we oppose Michael Oren's visit to UCI, one must consider his professional and military background. Oren personally participated in the Israeli Defense Force in wars that took place in Lebanon and Palestine. Oren took part in a culture that has no qualms with terrorizing the innocent, killing civilians, demolishing their homes, and illegally occupying their land. Oren is an outspoken supporter of the recent war on Gaza and stands in the way of international law by refusing to cooperate with the United Nation's Goldstone Report a fact-finding mission endorsed by the UN Human Rights Council. The Goldstone Report accuses the Israeli government of committing war crimes and possible crimes against humanity in the densely populated Gaza Strip.

As people of conscience, we oppose Michael Oren's invitation to our campus. Propagating murder is not a responsible expression of free speech. Oren and his partners should only be granted a speakers platform in the International Criminal Court and should not be honored on our campus.

 - We did exactly what we wanted to do
- Outcome
 - We need to brace ourselves

- Yasmin harassed
 - Everyone okay at the end of the day
 - But they realized she was the leader of the group and started attacking her without touching her
- The ambassador left for a while in the middle of the event but it looked stages
 - He looked genuinely angry though
 - He had trouble finishing his sentences after her came back to continue the speech
 - Probably was planned – someone warned a sister at the front of the room that MSU will be disrupting every 5 minutes
- When we started doing disruptions, there were people with cameras putting it in the sisters faces
- Bad distribution of brothers – sisters were mostly isolated on the right side of the room, the bros were mostly on the left side so the sisters there were pretty safe
- Threats
 - Sr.Hedaya got threatened by a guy
 - Someone walked over to AbdulRahman and said “your all gonna die”
- One of the policeman even said that he cant guarantee our safety
- What should we have done differently?
 - Seating arrangement were bad, not strategic enough
 - We should come earlier
 - **Safety - Seat sisters better!**
 - Have surveillance bros who check for seating, lines etc. “scouts”
 - Space out 2 mins more (rather than 30 sec) to get through it all
 - Back-up way of contact (because Mohamed was threatened that he’d be arrested if texting)
 - Educate people
- Did we accomplish our goal?
 - The ambassador probably wont be coming back, he looked really angry
 - Program was supposed to end at 8 but it ended at 6:47
 - From the time that the disruptions started, no one was paying attention
 - Showed them our presence
- Action Item
 - Everyone send videos to Suleyman Kazmi & CC Mohamed Abdelgany
 - Follow-up with media and public (unlike Daniel Pipes event)

The UCI MSU's position is that it was irresponsible of the university, as well as the law school and the political science department to organize and co-sponsor an event for the Israeli ambassador to speak at the university. By doing so, the college Administration has implicitly expressed its support for Israel's immoral and inhumane policies, including possible war crimes.
2. The MSU was neither involved in nor organized the protest in response to the Administration's invitation to the Israeli ambassador to speak at UCI.
3. The MSU believes in one's right to speak freely, whether it is the Israeli ambassador's right to promote Israel's propaganda on campus or individuals who disagree with the Israeli ambassador.

The members of the Muslim Student Union at the University of California, Irvine, condemn and strongly oppose the presence of Michael Oren on our campus today. We resent that the Law School and the Political Science Department have agreed to cosponsor a public figure who represents a state that continues to commit human rights violations, thereby breaking international law and law of Israeli accord. We strongly condemn the university for cosponsoring, and therefore, inadvertently supporting the ambassador of a state that is condemned by more UN Human Rights Council resolutions than all other countries in the world combined.

A year after the war on Gaza, in which 1,400 people were massacred, 700 of whom were women and children, Israel attempts to hide the war crimes it has committed behind the deceitful facades of so-called “academics” and “diplomats”. These public relations campaigns aim to secure more than three billion dollars of American taxpayer money that supports Israel’s military forces on an annual basis. The United States is going through the worst economic recession since the great depression, our tuition as UC students is increasing by more than 30% this year, our classes and services are being cut, and yet we continue to supply Israel with billions of dollars worth of brutal and illegal weapons used to oppress and inflict further suffering upon the Palestinian people.

To further understand why we oppose Michael Oren’s visit to UCI, one must consider his professional and military background. Oren personally participated in the Israeli Defense Force in wars that took place in Lebanon and Palestine. Oren took part in a culture that has no qualms with terrorizing the innocent, killing civilians, demolishing their homes, and illegally occupying their land. Oren is an outspoken supporter of the recent war on Gaza and stands in the way of international law by refusing to cooperate with the United Nation’s Goldstone Report a fact-finding mission endorsed by the UN Human Rights Council. The Goldstone Report accuses the Israeli government of committing war crimes and possible crimes against humanity in the densely populated Gaza Strip.

As people of conscience, we oppose Michael Oren’s invitation to our campus. Propagating murder is not a responsible expression of free speech. Oren and his partners should only be granted a speakers platform in the International Criminal Court and should not be honored on our campus.

Thanks for contacting us! My name is Hadeer Soliman, and I'm the Public Relations coordinator for the MSU. I'd be happy to give you the information you need for your article.

First of all, as I'm sure you're aware, the MSU is a multifaceted group that caters to spiritual, social, political, and humanitarian needs on campus. It is important to realize that the MSU plays a positive role in campus life, and to look at the MSU purely through the lens of our political activism is unfair and inaccurate.

In response to your question about our involvement, the MSU did NOT organize the protest in response to the invitation of the Israeli ambassador to speak at UCI, and the individuals who spoke did so acting on their own accord.

With that said, the MSU has stated that the decision to host and co-sponsor a speech by ambassador of a state that has been condemned by more UN resolutions than other countries combined was an irresponsible one. In co-sponsoring, the university has implicitly expressed its support for Israel's immoral and inhumane policies, including war crimes.

The MSU believes in one's right to speak freely, whether it is the Israeli ambassador's right to promote Israel's propaganda on campus or individuals who respond to the Israeli ambassador and disagree with him.

In addition, every year, the MSU sponsors a week-long series of events on campus aimed at raising awareness about the occupation in Palestine. Through respected and distinguished speakers and discussions on the real issues, the MSU encourages discourse on the humanitarian crisis in Palestine.

Dear Muslim Student Union President and Officers,
Hello, this is David Lumb, Editor-in-Chief of the New University newspaper here on campus. I covered the Ambassador Oren lecture/presentation last night and was present for the entire chaotic evening. I received quotes from audience members but none from members of the Muslim Student Union. While interviewing some students, I was challenged in my question whether to include their affiliation with the Muslim Student Union or Society of Arab Students. I think it would be very appropriate, then, to get a statement from the current President of the Muslim Student Union in light of both the statement released yesterday by the Muslim Student Union condemning Ambassador Oren's presence on campus today and of the well-known history between the Muslim Student Union and the Anteaters for Israel, one of the groups that sponsored the event; the statement would comment on the actions of the students who spoke out during the lecture and were detained by UCIPD, as well as the level of involvement, if any, of the Muslim Student Union in these protests.

In addition, the testimony of the students/UCI community members who were detained is crucial to the story in communicating their experience to the public. If the MSU community knows any of the individuals, I earnestly request their aid in connecting me with them to share their side of the story. The article will be long and complex, and I am making every effort to present all sides of the story. If any members would like to comment in any way on the lecture/presentation, please have them contact me with this e-mail or by phone, which is listed below. Alternatively, I am open to setting up interviews in person on campus. Thank you in advance for your help, and don't hesitate to reply with any questions.
